BILL DOUGAN Candidate for National President National Federation of Federal Employees

I have been NFFE's National President since June 2009 and previously was NFFE National Secretary-Treasurer from 2007-2009. A 33-year member of NFFE, I have served in a number of leadership positions at the Local, Council and National levels during my prior career as a federal employee working for the U.S. Forest Service. I've been blessed to have my wife Libby by my side for the



last 37 years. We raised 4 sons and have 11 grandchildren and one great-grandchild.

I am a founder and the elected Chairman of the Federal Workers Alliance, a collective of 20 unions representing over 300,000 federal employees that works to shape government-wide workforce policy. I am appointed by President Obama as a member of the National Council on Federal Labor-Management Relations, working with top administration and agency officials to improve labor-management relations at federal agencies. I serve on a number of other federal and non-profit groups, such as the Employee Thrift Advisory Council, the Federal Employee Education and Assistance Fund, and the Federal Advisory Council on Occupational Safety and Health.

Since becoming National President, I have put a priority on revitalizing NFFE's organizing, recruiting and communications strategies while continuing to protect our Union's financial health through wise investment and spending of your dues dollars. These efforts have markedly increased NFFE's membership.

I am proud of all that we have accomplished together and how far our great Union has come, but we cannot afford to rest on our laurels. We face many challenges in the coming years so must remain vigilant and stand ready to defend the hard-earned rights we enjoy as members of NFFE. I believe I have demonstrated that I am up to that task. It has been an honor and privilege to serve these last three years as your National President. #### **BILL FENAUGHTY**

Candidate for National Secretary-Treasurer National Federation of Federal Employees

William Fenaughty was unanimously appointed to the office of National Secretary-Treasurer by NFFE's National Executive Council in July of 2009. A 34 year veteran of the federal workforce at the Watervliet Arsenal and nearly 30year union member, Fenaughty holds extensive representational experience as both a local and national union officer.



As National Secretary-Treasurer, Fenaughty has overseen two consecutive years of budget surpluses, guiding the union to sustained financial well-being. In October of 2010, he was appointed by President Barack Obama to serve as a member of the Federal Salary Council, an advisory board that makes recommendations to the President's Pay Agent on locality pay adjustments and surveys. He has also led the charge to transition all NFFE Locals to Electronic Fund Transfer, a system which allows Locals to maintain and receive their finances faster and easier.

Prior to assuming the office of Secretary-Treasurer, Fenaughty worked as National Assistant Directing Business Representative (ADBR) from 2002-2009, a position in which he led NFFE's Business Representatives through a prosperous period of growth in both union membership and influence. As ADBR, Fenaughty successfully negotiated countless collective bargaining agreements for Locals from a wide variety of agencies, conducted national and local steward/officer trainings, and lobbied extensively on federal workforce issues. From 1998-2000, Fenaughty also served as NFFE National Region 1 Vice President.

Before joining the civilian federal workforce in 1973, Fenaughty served in the United States Navy from 1964-1968. He attended SUNY at Albany and is a graduate of the National Labor College, holding a Bachelor of Arts in Labor Studies.

I have announced my candidacy for National Secretary-Treasurer at the NFFE National Convention in Portland, OR in the fall. Since being appointed to this position in July 2009 I believe that NFFE has grown and prospered during my tenure in this position. I am looking forward to more new challenges as your Secretary-Treasurer. With all your assistance and support I am confident that we can move this great Union forward for the next four years. #### **ROB** ARNOLD

Candidate for National Vice President National Federation of Federal Employees

I currently serve as a NFFE Vice President, as well as President of NFFE Local 1998. Although not part of any council, Local 1998 is a nationwide local, with membership levels on par with NFFE councils. I received much of my labor training from former NFFE Vice President Colin Walle. I've served regionally as a Senior Steward, and nationally as Local 1998's Secretary Treasurer and Vice President, prior to becoming President.

I was a principal contributor to a negotiability submission that the FLRA found in NFFE's favor last year (concerning the right of Unions to negotiate on office moves and layout). I also played a major role in a prior decision (60 FLRA 34) which is often-quoted regarding Union rights in compressed work

schedules. That 2005 decision proved useful for a CWS termination grievance I filed last year. On June 25, 2012, an arbitrator ruled in our favor on the grievance, finding the agency owes hundreds of thousands of dollars in back pay to the Houston BUE for terminating their 4/10 schedules.

On May 22, 2012, I negotiated a settlement with the Department of State that returned one thousand dollars of improperly-withheld dues money to NFFE's bank account. The same month, I assisted President Dougan and General Counsel Sutich in drafting revisions of NFFE's existing bylaws.

I've submitted written testimony for Senate Congressional hearings on passport integrity. I've prepared and presented tutorials specific to our bargaining unit at the Winpinsinger Education and Technology Center.

My wife, Mary, is a former Union representative in a Seattle public defender office. My five-year old son, William, knows Click-Clack-Moo by heart. His infant brother, Allen, does not, but nevertheless endorses my candidacy.

BRYAN CLONTS Candidate for National Vice President National Federation of Federal Employees

Raised in Washington, DC, Bryan Clonts is the eldest of six kids. His father a Forest Service employee, his Stay-at-Home Mom a babysitter for kids of other federal employees, his parents taught values of hard work, commitment, and self-reliance. His dedication to those principles and discipline has made him an effective, respected leader and Union activist.



When Bryan left private industry as Marketing Director of a fortune 500 company, after playing and coaching semi-pro football and owning and operating a nationally recognized collectibles store, he chose a much more personally rewarding career as one of the 1.9 million federal employees, serving alongside some of the most generous, hard-working, and patriotic Americans.

In 2008, he led efforts in resurrecting his Local, which had only four dues-paying members, building it to a present active membership of 46 in a Bargaining Unit of 300. He was voted President of Local 125 in 2009. Concurrently with his job and Union duties, Bryan has championed a social organization that works on behalf of Forest Service Employees in need and strengthened its success in fund raising and moral boosting activities.

Recently Bryan began serving as a contributing member of NFFE's Young Federal Leaders organization. He's also served as a member of the NFFE Disability Forum.

Bryan works tirelessly on behalf of all government employees. His perseverance and love for building and leading a successful organization make him the right choice for the position of NFFE National Vice President.

He was instrumental in slowing down implementation of competitive sourcing in the Forest Service during its early years and finally in securing legislation to shut it down completely. He became Chair of the Legislative Committee in 2007 and has led several delegations to Washington, DC to meet with Congressional representatives and staff.

Mark was elected NFFE-FSC Vice-President for Research in 2008 and held this position until his election as NFFE-FSC President in 2011. In addition, from 2009-2010 he served as a negotiator on the national collective bargaining agreement between NFFE-FSC and the Forest Service.
