# NFFE-FEEA 2013-14 RICHARD N. BROWN MEMORIAL SCHOLARSHIP PROGRAM ELIGIBILITY AND APPLICATION PROCEDURES



In honor of Rick Brown's (1961-2009) unstinting devotion to federal employees and to his Union family, the Richard N. Brown Memorial Scholarship Program was established in June 2009. Rick's commitment to helping others achieve their goals goes on in his absence with college scholarships for NFFE members and their families. This year's program will provide 2 scholarships worth \$1,000 each. Eligible applicants will also be considered for FEEA scholarships.

### **BASIC ELIGIBILITY REQUIREMENTS**

- The NFFE-FEEA Scholarship Program is for current civilian federal employees who are members of NFFE and their dependent family members (spouse/child). Adult children and other relatives are eligible if claimed on the sponsoring employee's tax return.
- The applicant or the applicant's sponsoring federal employee must have at least three (3) years of civilian federal service by August 31, 2013. Past active duty time will count toward this requirement if included in the service comp. date on the Standard Form 50. No additional consideration is given for service beyond the minimum requirement.
- The applicant must be at least a college freshman by the fall 2013 semester.
- All applicants must have at least a 3.0 cumulative grade point average (CGPA) unweighted on a 4.0 scale. Current college freshmen must have a minimum 3.0 GPA for the fall 2012 semester.
- All applicants must be current high school seniors or college students working toward an accredited degree and enrolled in a two- or four-year undergraduate, graduate or postgraduate program.
- Applicants who are dependents must be full-time students. Applicants who are federal employees may be part-time students.
- The applications of current federal employees and their legal dependents will also be included in the general FEEA scholarship contest. Retirees and grandchildren who are not the legal ward of the NFFE member are not eligible for the additional program.

## **APPLICATION AND NOTIFICATION PROCEDURES**

- ✓ All applicants must submit a complete application package postmarked no later than March 29, 2013.
- ✓ It is the applicant's responsibility to ensure the application package is complete and on time. This includes transcripts sent directly by a school. FEEA does not notify applicants when items are missing. Applications with items missing after the deadline has passed are considered incomplete. Incomplete or late applications will not be considered or acknowledged.
- ✓ Acknowledgement receipts are e-mailed to eligible applicants who submit a complete application by the deadline. Processing and e-mailing of receipts may take 8-12 weeks after the deadline, due to the volume of applications received. Applicants desiring earlier confirmation of delivery should use a mailing service that provides delivery confirmation. Please add confirmation@feea.org to your address book to ensure receipt of your confirmation e-mail.
- ✓ All applications MUST include one self-addressed #10 envelope with current first class postage.
- ✓ Applicants will be notified of their final status by October 31, 2013. Please be aware that our committees make every effort to deliberate and provide final results prior to the start of the school year, however, unavoidable delays do sometimes occur.

	Essay: Typed, double-spaced, essay not exceeding two pages on the topic: If you were to consider working for the federal government after you graduate, what job would you take and why? If you are already a federal employee, why did you choose the job you have?
	Written Recommendation/Character Reference: Please submit ONLY ONE written recommendation/character reference from a supervisor, coworker, community leader, teacher or counselor. Must be submitted with application package.
	<b>Transcript:</b> The transcript must show a cumulative GPA of 3.0 or higher. An official transcript is not required; photocopies of transcripts are acceptable. <i>High School Seniors:</i> Submit full high school career transcript AND report card showing Fall 2012 grades. <i>College Freshmen:</i> Submit a transcript that verifies at least a 3.0 for the fall 2012 semester. <i>Undergraduates &amp; Grad Students:</i> Submit complete post-secondary career transcripts, including fall 2012 grades. Transcripts from all colleges attended MUST be included. <i>Applicants not currently enrolled:</i> Submit a transcript from the last school attended.
	□ Check here if your transcript is being mailed directly by the school – it must be postmarked by the application deadline of March 29, 2013 and it is still the responsibility of the student to ensure it arrives on time. An official transcript is not required; photocopies of transcripts are acceptable.
