



CONVENTION CALL

In Accordance with Article IX, Section 9.1 of its Bylaws, the National Federation of Federal Employees FD-1 hereby issues this Convention Call.

NFFE's 52nd National Convention will be held at The Lofton Hotel in Minneapolis, MN, commencing at 9:30 a.m., Monday, September 16, 2024. The scheduled adjournment will be COB Thursday, September 19, 2024, or as otherwise determined by the Delegates in attendance.

Registration will open on Sunday, September 15, 2024, from 1 p.m. to 7 p.m. Registration will reopen at 7 a.m. Monday, September 16, 2024, and close at 9:15 a.m. Registration will be \$75 per delegate in attendance. Guest fees will be \$50 for guests age 12 and above attending convention events. Checks/Money Orders are to be made payable to National Federation of Federal Employees FD-1.

OFFICER ELECTION

The following National officer positions will be open for election:

National Secretary-Treasurer
7 National Vice President-at-Large positions
Trustee

Nomination and election forms and rules adopted by the Election Committee are enclosed. The term of office for each position is four (4) years.

CONVENTION DELEGATES

The number of delegates a Local lodge is authorized, the number of votes a delegate may carry and eligibility requirements are contained in Article IX of the NFFE FD-1 Bylaws.

For Local delegates to be seated, the Local must be in "good standing" with NFFE. To be considered in good standing, the Local must be in compliance with the NFFE Bylaws and the IAMAW Constitution. Any Local that is in arrears must pay off the amount owed by August 16, 2024.

Delegates from a Local must be elected as provided for in the Local's Bylaws. A Local may decide not to send delegate(s) to the Convention. Such a decision must be made by a vote of the Local's membership at a general membership meeting, and such vote must be recorded in the minutes of the meeting.

Delegates must have a copy of their delegate credentials to register at the Convention. Delegates carrying more than one delegate vote must have one valid credential for each vote they are carrying.

The number of delegate votes for each Local will be based on the membership count in remittance reports issued for the last full federal pay period in May 2024. Locals and Councils will be mailed the appropriate number of delegate credentials for each authorized delegate no later than June 30, 2024.

Every Local is strongly encouraged to have their delegates attend the Convention. If your Local is unable to send any delegates, make sure your votes are carried to the Convention, in accordance with Article IX, Section 9.5 of the NFFE FD-1 Bylaws.

BYLAW AMENDMENTS AND RESOLUTIONS

Also enclosed are forms for proposing amendments and resolutions and instructions for completing the forms. The forms may be reproduced as necessary. Additional pages may also be attached as necessary. Pursuant to Article XV, proposed amendments must be received at the NFFE National office by COB July 18, 2024. Pursuant to the Standing Rules Governing the NFFE Convention, Article II, resolutions must be received at the NFFE National office by COB July 18, 2024.
